# Do you or someone you know have head and neck cancer that has spread?

Learn more about a new clinical research study.



## What is a clinical research study?

Clinical research studies help researchers and doctors learn whether a study drug is safe and if it works to treat a certain disease or condition.

Each study has requirements for who can or cannot join. This is called the eligibility criteria. You can volunteer to take part in a study if you meet these requirements. You can choose to stop taking part in the study at any time.

You will not be paid to take part in this study, but you may be paid back for reasonable travel costs during your participation. Ask the study team for more details.

## Who can take part in STELLAR-305?

- You may be eligible if all these apply $^*$  -

- You are at least 18 years of age
- You have head and neck cancer that continues to grow or spread
- You haven't had treatment for your head and neck cancer, or prior treatment happened before the cancer spread



## **About the STELLAR-305 study**

STELLAR-305 is a clinical research study to see how the drugs pembrolizumab and zanzalintinib work together when used as a first treatment for head and neck cancer that has come back (recurrent) or spread to other parts of the body (metastatic).

People in the study will be put into a treatment group. Everyone in both groups will get the standard treatment of pembrolizumab combined with either the new study drug or a placebo.



You and your doctor will not know which group you are in.

During the study, you will:

- Visit the study doctor 2-3 times per month for treatment and tests
- · Have your health checked and be watched for any side effects

You may stay on the study as long as you benefit from the study drugs or until the study doctor thinks you should stop.

<sup>\*</sup>There are other eligibility criteria you must meet to join the study.
